## TPFVHAI CIRCULAR 2021-02: VILLAGE COVID-19 MEASURES

Dear Association Member,

We hope everyone is safe and well.

The Department of Human Settlements and Urban Development in a memorandum dated 01 May 2020 empowered homeowners' associations to closely regulate the ingress to and egress from their villages to mitigate the spread of the COVID-19 virus. This, together with IATF and local government regulations, guided our work resulting in the release of at least eight (8) circulars on Village Covid-19 Measures within a period of six months in 2020. Our work continues and we kindly ask you to work with us in remaining vigilant.

May we kindly remind you that Batangas province remains under GCQ and that our Village Covid-19 measures remain in effect. *To avoid any inconvenience, kindly take note of the things you should know before heading to Terrazas:*

### TERRAZAS VILLAGE COVID-19 MEASURES: KEY THINGS TO REMEMBER

- **Max. 10 Guests\* Rule** – per address, per day, entry of max. 10 guests is allowed; association member and immediate family members are NOT counted;
- **Health Declaration Form (Health Dec.)** – an IATF requirement intended for contact tracing, this form is required upon entry in Terrazas; hardcopy and QR code are available; required for ALL
- **Wearing of Masks, Temperature Check** upon entry – required for ALL (association members, immediate family members, guests, regardless of age)

#### FOR GUESTS\* ONLY

- **Med/Health Certificate (Health Cert.)** – required for all guests coming from outside Batangas; *document must state that patient does not show any Covid-19 symptoms and is safe and healthy enough to travel; valid for 4 days only from arrival date;*
- **No Entry for Unaccompanied Guests** – guests who arrive when association member has not yet arrived or is not physically present inside Terrazas need to wait at Central Parking reception; guests are not allowed to stay overnight and beyond in Terrazas in the absence of the association member/homeowner; \*no entry for unaccompanied guests rule applies to Amara Condo, Peak/Ridge and Club Punta Fuego; no Amara condo owner, Peak/Ridge homeowner or club member present, no entry for guests;
- **Use of Guest Lane** – all guests pls. follow “guest lane” directional signage going to reception area to register;
- **Request for Guest Entry Form** – a form registering association member’s guests to be signed both by member and guest; pls. be ready with government-issued IDs.

*\*Guests = non-association member and are not immediate family members of association member; \*\*Immediate family member = association member’s spouse, children, parents or siblings.*
