\*Day Guest: Written message via internet-based messaging application providing the date of visit, names of the guests, and purpose of visit is requirement before the arrival of guest. Unaccompanied Day Guest shall be made in writing on a Guest Entry Form.

\*Overnight Guest: Endorsement shall be made in writing on a Guest Entry Form, submitted in person or sent by email to the TPFVHAI PMO at least 48 hours before the arrival of guests. \*Unaccompanied Guest - a guest not continuously accompanied by the endorsing Member or his/her immediate family while inside the village.

\*Each Association Member is allowed to accommodate a maximum of thirty (30) unaccompanied guests per month. Any unaccompanied guest in excess of the thirty (30) unaccompanied guest per month shall be fined P1,500 per guest per night, charged to the account of the Association Member.

#### **UNDERTAKING**

I hereby agree to abide by the duly established and existing Terrazas Village Rules and Regulations.

I take full responsibility for all the acts of my guests and shall be fully accountable for any violation of Terrazas Village Rules and Regulations.
