**2. Association Member Information**

This section must be filled out by the Association Member whose name appears on the Transfer Certificate of Title of the Property. Provide the needed information indicated in this form. If the property is registered under a corporation, please fill-out MIS for corporate members

**3. Association Member Spouse**

If married, fill in your spouse's details.

**4. Immediate Family Members of First Degree of Consanguinity and Affinity**

Please fill-out the details of your relatives such as parents and children, to whom you are authorizing access to your property. You may also tick the box beside their name if you are authorizing them to endorse visits to your property on your behalf.
